SECTION 4: FIRST AID MEASURES.

4.1 Description of first aid measures.

Inhalation.

7.1 Precautions for safe handling.

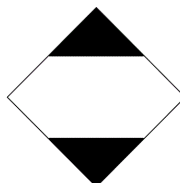
